## **1 PURPOSE**

This paper provides a model of the PNC Wanted Missing (WM) file within the CorDM. The Person-related data held for a Wanted/Missing person has been incorporated into the Person strategic class and is not replicated here.

## **2 BACKGROUND**

The PNC Wanted Missing Persons facility brings to operational officers on a nation-wide basis a one-stop-shop from which an officer can see whether or not some action should be taken when a person is encountered. There are many reasons why action should be taken and these have been reduced to a generic set of reports on the application. In effect these reports are a specific view of a variety of business activities and information that give rise to them. Taking this approach the content of the application's reports has been analysed with the intention of revealing the underlying objects that they represent and modelling them within the framework of the CorDM.

## **3 DATA MODELLING NOTES**

Every WM report type contains the following data items:

- Reference
- Location Of Case Papers
- Incident Date
- Reported Date
- Free Text.

In Table 1 below the Extra Data Items column shows the additional data content for the report types on the current application and indicates how the report types are modelled within the CorDM. It is hoped that this table will aid those familiar with the Wanted/Missing application to understand how the current physical design has been mapped to the CorDM.

Table 1 is divided into UK and Foreign processes. The application makes no distinction except that it has a foreign offence marker when a person is wanted under foreign legislation. However, the business activity that leads to the creation of a 'foreign report' is different from that for a 'UK report' since the report emanates from a notice from ICPO (International Criminal Police Organisation) rather than an UK incident, warrant, etc.

1	Event-related Circulations	Presents activities that are performed within the police service, principally Incident and Crime, that result in a person being sought by the police.
2	Information-related Circulations	Presents activities that are performed outside the police service, principally by the courts, that result in a person being sought by the police.

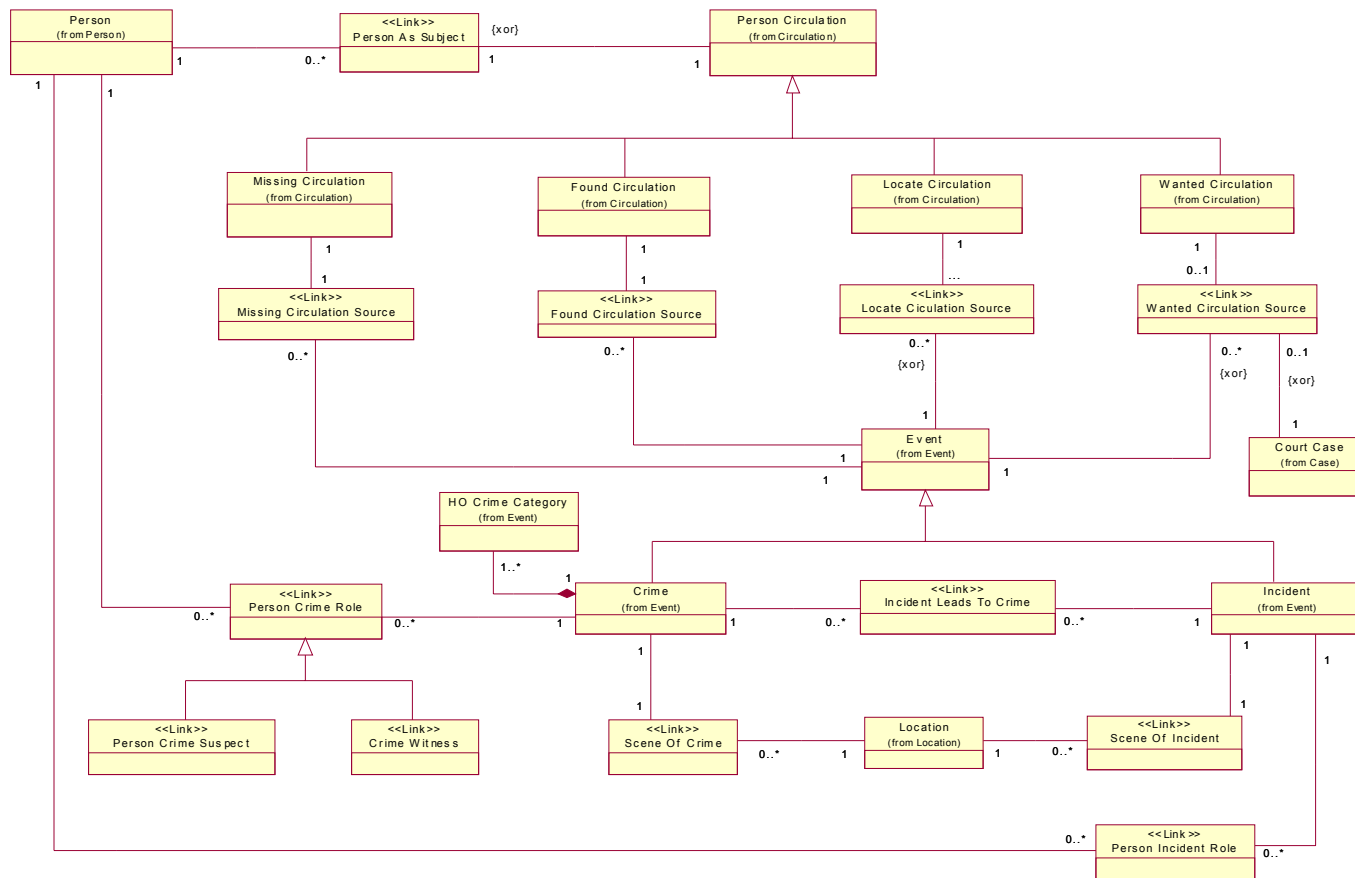


Figure 1: Event-related Circulations

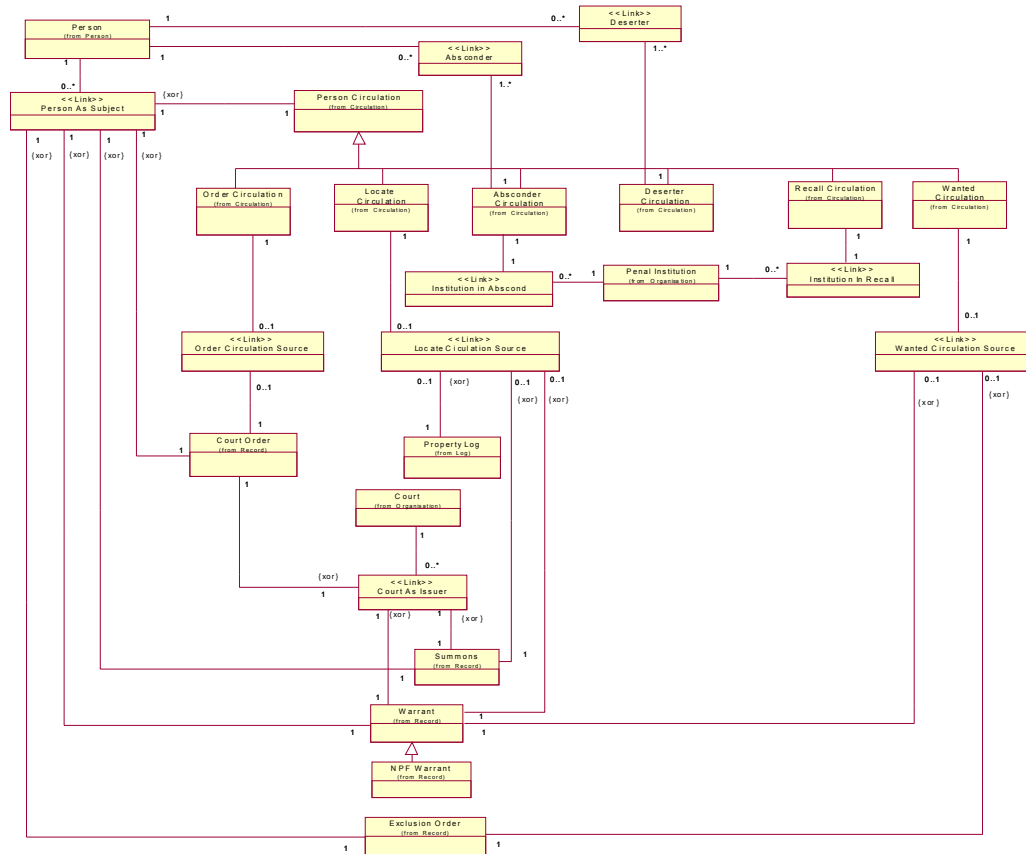


Figure 2: Information-related Circulations
